Administrative Division Reports

- Executive Director: Mary Turner reviewed some decisions that the Board needs to make regarding Flex members. The Board decided:
 - Flex members will not be allowed to participate in District, Region, Summer Awards, Age Group, or Senior Champs.
 - Flex members will not be subject to fines for participating in meets above the 2 allowable sanctioned meets.

She then reviewed information that she had gathered concerning the feasibility of hosting 2019 Zones at Liberty Natatorium. Mary explained that the hotels in the area could handle the needs of the teams as long as teams follow suggested guideline as to where they could stay. This caused concern as attending teams have never been 'assigned' the hotel by the host.

- A motion was made and seconded to host the 2019 LC Eastern Zone Age Group Championship meet at Liberty University Natatorium. The motion failed.
- Mary will inform the Lynchburg hotels of this decision and will also notify the management at CSAC that we will host the meet at their facility in 2019. Due to the concerns expressed about hosting the meet in Lynchburg in 2019,

Mary suggested that we will need to think carefully as to whether we should submit a bid for 2020 LC Zones at Convention. Nothing about the amenities available in Lynchburg is likely to change prior to the time the bid will need to be submitted.

- Technical Planning Jessica Simons had two items to discuss:
 - She asked the Board to consider a problem with a meet where a 12 & Y session exceeded four hours. She indicated that the meet host did not follow her suggestions for remedying the situation. Currently there is nothing in our Policies to enforce compliance. It was decided that a warning letter will be sent to the meet host by John Stanley.
 - She also reported that she requested proposed meet financial reports from teams that submitted bids for 2019 LC Senior Champs. The information that she has received was included with her report. It was decided to wait until after this year's LC Senior Champs meet at Liberty to finalize the decision for 2019.
