



OQM Meet

- Criteria:
 - -MR-N2 or N3
 - May be an evaluator, if not, must have a National Evaluator
 - Must run meet using deck protocol at higher level National caliber meets
 - Meet length must be at least 2 days 4 session- P/F format
 - Expected to attract and capture national caliber swimmers
 - Fully automatic timing system
 - Application submitted to NOC

N2 Evaluators/Members

- Officials Chairs select N2 Evaluators
 - Hold N3 ST certification & N2 certification in position they are evaluating
 - Has attended National Championship meet (3 star and above) within last 3 years
 - Actively participates in LSC meets including Championship meets
 - Successful deck mentor to apprentices w/in LSC
 - Knows rules, jurisdictions, protocol

N2 Evaluators/Members (cont)

- Characteristics:
 - Patient
 - Thoughtful
 - Communicates well and often
 - Values volunteers
 - Apprentices respond to teaching
- Leads by example

N3i Evaluators

- List maintained by National Officials Committee (NOC)
 - Prerequisites for N3i CJ, DR, AR, SR:
 - Current N3 ST and N3 certification in position evaluating
 - Positive performance evaluation in recommended National Evaluation position two times at National (3-star or above) meet
 - Officiated in some capacity at Jr, or Sr Nationals in past 3 years
 - Written recommendation for N3i evaluator position by the applicants LSC Chair or another N3f in that position.

N3i Evaluators

- Minimum of two teaching and learning activities in OTS in the past 18 months
- Independent review/confirmation by three FINA officials

Deck Referee	2	1
Admin Referee	3	0

N3i Evaluators

- FINA Officials will
 - Recommend or Recommend with action plan
 - Not recommend
 - No opinion/Do not know applicant
- NOC members may be asked to review recommendations as necessary
- N3i evaluations are able to conduct N3 recertifications evals

N3f Evaluators

- List maintained by NOC
 - Prerequisites for N3f CJ, DR, AR, SR:
 - Must have served in that position at two National (3 star & above) with at least 1 of the 2 a 5 start meet
 - Must have successfully evaluated at the N3i level in the position evidenced by positive "evaluate the evaluator" in previous 4 years
 - The evaluator written N3i evaluations are reviewed by the NOC Evaluator subcommittee and NOC Chair
 - N3f must be provided in writing by N3f evaluator by NOC Chair and/or NOC Evaluator subcommittee chair.

N3f Evaluators

- Officiate in some capacity at National (3 star or above)
 meet in past 24 months
- Minimum of 2 teaching and learning activities in OTS past 18 months
- Active in LSC in past 12 months
